Superintendent Parent Brief March/April 2021 Considerations and Guidance for the Upcoming Weeks

Dear Ida Public Schools Community:

COVID cases are rising in our community and county. Please see the Ida Public Schools dashboard for our latest metrics. With spring break and the upcoming holiday, outside exposure could increase. Nurse Rozek will send an additional note with helpful health protocols to assist us. The following paragraphs will outline how we will respond as a district.

Increased COVID cases and exposure, and when would we close?

Nurse Rozek and I track the positive cases and their close contacts to see if we can identify a hot spot or excessive exposure in a classroom, common area(s.), athletic team or extra-curricular activity. We also follow those in quarantine for symptoms or cases that develop, the timeline of the cases and analyze this data. In the event we identify a pattern, we discuss with the Monroe County Health Department to determine if a closure is needed. Weighing the health metrics is not easy, every scenario is different and takes time to analyze. Please note, if a pause or closure is needed, the notice could be less than a day.

Another scenario that could close a building(s), hopefully for not more than a day or two (a pause), is time needed to complete contract tracing due to a positive case(s) report. Again, notice could be short.

Quarantine: I have communicated to staff and parents that quarantine numbers will not close us, shortage of subs could. We added additional commit subs for the next month in hopes we have the necessary staff should staff quarantine numbers rise. This is a similar step we might follow if we had increased influenza.

Instruction for students in quarantine: The teachers are learning creative ways to keep students current who are in quarantine, hoping to maintain the instructional, social and emotional engagement. I cannot thank the teachers and parents enough for helping the students stay on track and engaged. It is not easy.

If you or immediate family member test positive, please contact our school nurse Mackenzie Rozek at rozek@idaschools.org or 734 – 269 – 9003 ext. 1510 as soon as you are aware and keep your child home until you talk with her. If this occurs the week of spring break, thru Sunday April 11, 2021 please contact Janie Dressel at dressel@idaschool.org or 734 – 269 – 9003 ext. 4002. I will be available during spring break if you have questions or concerns. kreps@idaschool.org or 734 – 269 – 9003 ext. 4000. Again, Nurse Rozek's note will provide additional guidance.

If we continue to work together and follow the necessary steps and precautions, the chances for Ida to continue to operate safely and in-person is greatly increased.

I look forward to sharing the end of the year celebratory events with you. The events might look different, but the heart of the celebration will be the same!

Kindergarten Round Up For 2021-2022 School Year

Ida Elementary will conduct its Kindergarten Round Up registration on Wednesday, April 28, Thursday, April 29, & April 30, 2021. If you have a child who will be entering kindergarten this fall, you are asked to notify the Elementary office as soon as possible, with your child's name, child's date of birth, phone number, parents names, and address. The state of Michigan recommends that your child be 5 by September 1, 2021. You can reach the Ida Elementary office at (734) 269-3605.

A mailing will be sent to Parents the end of April notifying them of the exact day and time they are to attend. Parents will be required to provide:

- Child's original birth certificate
- Immunization record
- Proof of Residency for residents
- A Physical by their doctor a green physical form will need to be completed by the parent & doctor (these forms will be mailed to you or can be picked up at the Elementary Office)
- Hearing & Vision Screening Available at Monroe County Health Department (by appointment only) or by your own physician.

NOTE: The parent or legal guardian of children who are turning 5 between Sept. 2nd thru Dec.1st may enroll their child in kindergarten for the 2021-2022 school year if the parent or legal guardian notifies the school district with written consent.

Ida Elementary's "Safety City" Program — Now Accepting Applications

Parents of children who will be entering kindergarten or first grade are invited to take advantage of an exciting summer program, which provides youngsters with the opportunity to practice safety in many situations. *Depending on the guest speakers we are able to secure*, the following situations will be addressed this year:

Now in our 23rd year, the ten (10) day program will offer a morning session, lasting two hours per day (9:00-11:00 a.m. daily, except for "Graduation" day). Safety City is taught by Ida Elementary Teacher, Mrs. Alissabeth Fox. The Teacher Assistant will be Mrs. Carolyn Clark. The program features daily guest speakers who will talk to children on a variety of safety topics. Children in the class will experience learning in fun ways, including daily opportunities (weather permitting) to ride the Kettler Grand Prix Kettcars in the "Safety City." Children will also receive many free gifts during the course.

The dates of this summer's Safety City program will be from <u>Monday, 21 June through Friday, 2 July, 2021.</u> Parents are reminded that registration is on a "first come, first serve" basis, and the program is limited to 30 students.

Due to COVID 19, we are taking extra precautions with the program. Students will be distanced appropriately, and mitigation will be according to CDC guidelines at the time of the program.

Because we want our Ida children to experience this important course, we are offering Safety City to Ida families **ABSOLUTELY FREE.** NOTE: Children may not repeat Safety City.


